JULIE KRONE INJURED IN GULFSTREAM

SPILL Jockey Julie Krone, who returned to the saddle January 4 after nearly two months on the sidelines, suffered possible fractures of the left wrist and a finger on her left hand in a spill at Gulfstream yesterday. Krone was aboard Saratoga Source in the fourth race when the mare broke down and fell at the three-sixteenths pole. Jockeys Dave Penna and Heberto Castillo Jr. were also thrown while trying to avoid the fallen horse and rider but escaped injury. Krone, who underwent surgery Nov. 11 to remove plates and screws from her right ankle which was severely fractured in a spill at Saratoga in August, '93, was taken to Memorial Hospital in Hollywood, Florida for x-rays; doctors have said if there is no ligament damage in the wrist, she could be back riding in four to six weeks. Saratoga Souce suffered a fractured left front leg and had to be destroyed.

CALIFORNIA HORSEMEN CLEAR THE AIR

Prompted by a series of recent events including the threatened January 1 walkout by the jockeys, the refusal of some riders to give interviews to the media and possibly questionable circumstances surrounding the cancellation of racing at Santa Anita last Sunday, a meeting between members of the California Horsemens' Benevolent and Protective Association and the local jockey colony was held at Santa Anita yesterday. "There's been hard feelings, back and forth," said trainer Richard Mandella, spokesman for the CHBPA Board of Directors. "We expressed the problems that have come forth over the last month, and our willingness to work together to promote racing and not detract from it. The jockeys could not have responded better." Mandella said that the CHBPA's main concern was the possible misconception of the riders' intentions; it had been rumored that Sunday's cancellation, which was caused by the riders' decision that the track was unsafe, was in some way related to the aborted strike. Remarked jockey Kent Desormeaux, "I've been riding here 10 years and I've never once sat in on a meeting with fellow members of our industry. We cleared the air on several issues, but the important issue to me was opening the lines of communication. That was wonderful."

Luthier Fever

As the West Coast disappears into the Pacific Ocean, it's important to remember an important maxim--in handicapping races to be run in the slop, the most important consideration is ability (or lack of it) shown in previous starts on off tracks. Saturday's San Fernando quickly boils down to favorites Strodes Creek (Halo), Dramatic Gold (Slew o'Gold) and Wekiva Springs (Runaway Groom), but we like one much better than the others.

Jones

When Strodes Creek surfaced a year ago, he broke his maiden as first asking in a sprint, then improved his Thoro-Graph figure in four consecutive starts, peaking with a big Kentucky Derby figure in the slop. He returned from a six-month layoff recently with a strong figure in a sprint, and now gets a distance and surface he clearly relishes. Additionally, all indications (pedigree, physical type and trainer) point to strong development with age.

Wekiva Springs and especially Dramatic Gold are top horses, but they get the worst of it here. Neither has raced on an off track, and they will be giving weight to the "now" horse. Strodes Creek to win the San Fernando. Thoro-Graph sheets, state-of-the-art performance figures, are used by many industry professionals to evaluate the ability of racehorses. The defection of champion Timber Country will likely leave the role of favorite to Jumron (GB) (Sharpo). PENNY'S RESHOOT PUT DOWN Penny's

Reshoot (Turkey Shoot), winner of the GII Prioress S. at Belmont in June, was put down yesterday due to an infection which did not respond to treatment, according to her trainer John DeStefano Jr. "She broke down during her last race in Maryland (when finishing second in the GIII Columbia S. September 24), but that's not the reason," said DeStefano. "She ran down in that race and got an infection in her tendon, which then went into her bone." A month ago, doctors at the New Bolton Center in Pennsylvania tried to remove the infected part of the filly's bone. But Tuesday, when it was clear the procedure was not working, the owners of Penny's Reshoot made the decision to have her humanely destroyed.

VIDEO LOTTERY FOR FLORIDA TRACKS?

Just a few months after voters defeated a bill to allow casino gambling, a group representing Florida iai alai and dog tracks has submitted legislation to the House Regulated Industries Committee which would allow the state's 31 parimutuel facilities, including the four Thoroughbred tracks, to open poker rooms and install video lottery machines. Responding to the proposal, Gulfstream Park President Doug Donn said, "If the state allows them, we would install them," but added, "I won't oppose the card rooms, but I'm not going to support them. Unless we as an industry go to Tallahasee with a detailed comprehensive package for our benefit, we could walk away without any programs." Donn feels that racing would better be served with the establishment of phone betting, offtrack betting parlors and a television network.

SUFFOLK DOWNS CANCELS FRIDAY Suffolk Downs was forced to cancel it's Friday card after the

second race due to unsafe tracks conditions caused by thawing temperatures. The Massachusetts oval is scheduled to resume racing today.
