

## NUNN'S ATTY. CHARGES HISA WITH HYPOCRISY IN DEALING WITH INTRA-ARTICULAR INJECTIONS

Attorney Drew Mollica understands that his client trainer Doug Nunn violated Horseracing Integrity and Safety Authority (HISA) Rule 3313, which prohibits trainers from running a horse within 14 days of an intra-articular joint injection or working them within seven days of the injection.

What he doesn't understand is why his client has been suspended while at least 15 other trainers have been let off the hook for the same violation.

"This is the height of hypocrisy," Mollica said. "He has been victimized by a system that is flawed."

On June 26, HISA announced that it had temporarily suspended full enforcement of its intra-articular joint infection rules and that the rule covering workouts would not go into effect until July 15. According to HISA Chief Executive Lisa Lazarus, between 15 and 20 trainers had breached the rule surrounding intra-articular joint injections prior to a workout. Lazarus said the delay in implementing the rule was needed because there was confusion among trainers regarding the specifics of the rule.

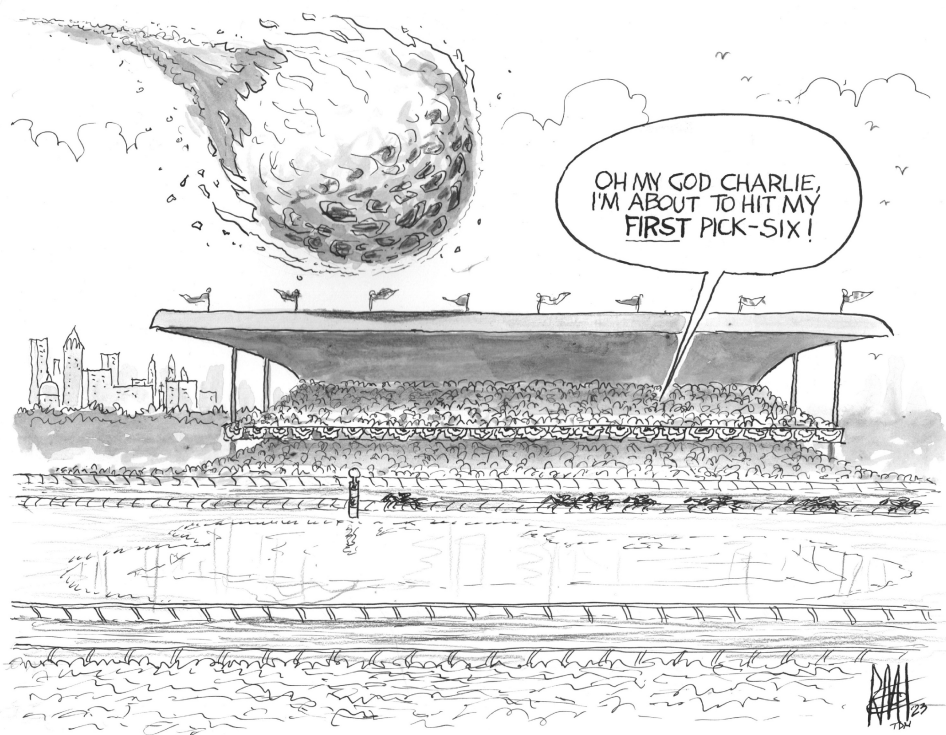

"On the workout side, while it was mentioned in the education process, it seems that a lot of trainers just really didn't understand it, and most of the violations we saw were only off by one day," she said. She added that the temporary modification of enforcement of the rules was deemed the most "fair and equitable" way to proceed "given the number of violations."

Alexa Ravit, the director of communications and outreach for the Horseracing Integrity and Welfare Unit (HIWU), confirmed in an email to the *TDN* that Nunn's penalty was not excused because the injection was too close to a race while the other offenders were too close to a workout.

According to Mollica, the horse in question, **Smithwick's Spice** (Frost Giant), was injected 12 days before racing on June 9 in an allowance race at Delaware Park, which the gelding won by three-quarters of a length. That, he argued, is less egregious than working a horse within seven days of an injection.

"The people who made the mistake of working within seven days put more stress on their horses than he did in the 12 days between the injection and racing," he said. "The racing-versus-the-work argument is not logical because his horse had more time to recover."

Mollica also said that if HISA had been doing its job the entry of the horse would not have been allowed.

"Doug Nunn's horse had an injection and it was reported on the horse's portal on May 31," he said. "Everyone knew about it. HISA was supposed to now flag his entry. The horse was supposed to be ineligible to race. But they, maybe because of confusion, didn't do it. Doug Nunn was confused about the rules and didn't talk to his vet and didn't coordinate things properly. He entered the horse. The overnight was out eight days before the race. HISA never said 'Wait a minute, Doug, your horse isn't eligible.'" **Cont.**

Mollica continued: “They let him run on June 9. He wins on June 9. There was confusion as to what he was supposed to do. But Doug Nunn, as opposed to, fill in the blanks, the trainers who they let off, was treated differently. Those guys got a pass. That’s not America to me.”

Mollica said that if possible confusion about the rules was the reason why trainers who violated the workout provision of the rule weren’t suspended then there’s no reason why the same argument shouldn’t apply to racing a horse in violation of the rule.

“In this situation, there obviously was confusion,” he said. “How do I know? Because HISA themselves dropped the ball. Delaware Park was confused. HISA was confused. Doug was confused. Why is his any confusion any different than their confusion?”

Mollica also wants to know what trainers violated the workout rule. Although any possible suspensions were waived, their horses were ineligible to race within 30 days of the injection, which Mollica, argues, should make the names of those horses a matter of public record. He pointed to the [June 29 story in the TDN](#) in which Lazarus implied that the names of those horses would be released.

“When horses are suspended, you’ll be able to figure that out,” Lazarus said at the time, pointing to HIWU’s “public disclosures” webpage.

However, the names have not been disclosed and a request to HIWU by the *TDN* to release the names of the horses involved was denied.

“Since the trainers were not Provisionally Suspended and Charge Letters were not issued to them because they only received a warning (as per HISA’s notice), HIWU will not be publishing the names of the horses currently facing a 30-day period of Ineligibility due to breezing too soon after an IA injection,” Ravit wrote to the *TDN* in an e-mail. **Cont.**

“For IA-related matters after July 15, the names of both the trainers and the horses will be published once a Charge Letter is issued to the trainer.”

But HISA's own rule 3620 makes it clear that public disclosure is required. It reads:

**Rule 3620. Public Disclosure**

(a) The Agency shall Publicly Disclose the resolution of an alleged violation of the Protocol no later than 20 calendar days after:

- (1) the final decision;
- (2) a resolution between the Agency and the Covered Person; or
- (3) the withdrawal of a charge or a final decision finding of no violation

Why won't HISA/HIWU release the names of the horses that worked within the seven-day period, even though their own rules say they must? Mollica said he didn't want to speculate but he was quick to fault them for a lack of transparency.

“My problem is the lack of transparency and the lack of fairness,” he said. “What's good for the rich and famous trainers should be good for Doug Nunn. The lack of transparency shows because Lisa Lazarus said you'll know the names of those trainers when we publish the names of the suspended horses.

Now we understand they are not going to release the names of those horses. Meanwhile, Doug was publicly villainized with his ruling up there on their website, yet we don't even know who these people who were given a pass are. So tell us. Transparency is the greatest disinfectant. We obviously have an infection. Why are we not disinfecting it?”

Nunn's violation can yield a suspension of up to 60 days but Mollica said he has reached an agreement with HISA and HIWU and that his client will receive a 30-day suspension. The situation has left him asking a lot of questions and he doesn't have all the answers, but he believes that Nunn was treated differently because he's a small-time trainer. Based at Monmouth Park, he's won six races this year from 59 starters and has 305 career victories.

“If you are going to start opening up loopholes, you can't open up loopholes for some and not for others,” Mollica said. “Doug Nunn is a victim of being a small guy in a big world. I do think he's being treated differently, like a lot of little guys are. This is stacked against the little guy. They excoriated Nunn and let others off and they won't even tell us who they are.”

He was this week's **Green Group** Guest of the Week.

"The HISA regulations are written in a way that is truly evil," Pincus said.

His complaints were many, starting with how violations of banned substances are dealt with by HISU. Once a positive has been determined for substances that are on the banned list, the trainer involved is immediately suspended. That takes place before a hearing can be held and before the results of a split sample are received.

"They give you very little chance to defend yourself," Pincus said. "The worst part of it is that when you have a banned substance, they come to you. They give you a letter that says you have a positive for this drug. They tell you 'get out' and you're out that next day. What happens to a trainer who is told to get out? Their horses must be relocated to different trainers in different stalls. You lose your owners, you lose your horses, you lose your ability to make a living. In the case of Mr. Dominguez, he had a dozen horses. He was a small trainer working his way through and was doing okay. But like most trainers, he is living month to month. Now you've taken away his ability to make a living. You haven't charged him with anything, but he's dead. That's against due process."

He continued: "He's yet to be charged with anything. They won't charge you until the split sample comes back. It's due momentarily. But his life has long since been over. He hasn't been charged with anything. What happens if the split sample comes back and it's under the level? What do they say? 'Oops, sorry that I destroyed your life.' The whole system is unconstitutional. It's based on the fact that you're guilty until proven innocent."

Pincus also opined that there are substances on the banned substance list that don't belong there, that should be treated as relatively minor issues.

"Mac Robertson (who also received a provisional suspension from HIWU) got a positive for Regumate, another very low-level drug," Pincus said. "It can't possibly be a banned substance. You're supposed to be looking for a Etorphine and EPO and things like that as banned substances. Not these things. It's ridiculous. You're going to see more, one a week. It's like Russian

roulette out there. These guys, they're not cheaters. And besides the fact, you have very little chance under their system of winning. It has to stop."

Pincus said the old way of doing things is preferable to a world under HIWU and the Horseracing Integrity and Safety Authority (HISA).

"They're not going to be able to do it better than the racing commissioners," said Pincus.

"The racing commissions know about the game. They have experience in the game. The stewards are the most knowledgeable people in racing. Now we've gone and replaced them with a bunch of people who say things like, 'Let's change the whip to a popsicle stick with a piece of cotton on the end of it and look at some grainy films and see if that was a jockey winding up or he actually hit the horse.' It's stupid. The seventh whip strike is animal cruelty? Then what was the

sixth whip strike, which is allowed?"

Elsewhere on the podcast, which is also sponsored by **the Pennsylvania Horse Breeders Association, Kentucky Thoroughbred Owners and Breeders, WinStar Farm, Lane's End, XBTv.com** and **West Point Thoroughbreds**, the team of Bill Finley, Randy Moss and Zoe Cadman jumped into the controversy surrounding the extension of Bob Baffert's ban by Churchill Downs. Moss predicted that Baffert would fight the extension in court and that, this time, he would prevail. The team also took a look back at the win by **West Will Power** (Bernardini) in the GI Stephen Foster S., run this year at Ellis Park, and the game victory by **Fort Bragg (Tapit)** in the GIII Dwyer S. Looking ahead at this weekend's action, Finley focused in on the GII Suburban S. at Belmont. A race with a long history and one won by some of the sport's all-time greats, the Suburban, Finley said, has turned into a second-tier race. He argued that there are too many races on the NYRA calendar for older dirt males and said the best solution would be to discontinue the Suburban, which, this year, drew only five horses.

## HBPA ON HISA: THIS COURT'S JOB IS TO AGAIN TELL CONGRESS 'NO' *by T.D. Thornton*

With oral arguments tentatively scheduled for the first week in October, the National Horsemen's Benevolent and Protective Association (NHBPA) and 12 of its affiliates told the United States Court of Appeals for the Fifth Circuit on Wednesday that the rewritten version of the Horseracing Integrity and Safety Act (HISA) remains "patently unconstitutional," and that the Authority overseeing the sport "is basically a private police department" whose sweeping powers equate to "oligarchic tyranny."

As the appellants in a lawsuit that has persisted in the federal court system for more than 27 months, the HBPA plaintiffs were allowed to file the first briefing in a landmark case for the Thoroughbred industry that has been put on an expedited schedule by the Fifth Circuit.

The defendants, who are personnel from the Federal Trade Commission (FTC) and the HISA Authority, have 30 days to craft a reply. They will make their filing knowing that a lower court in Texas has already ruled that an amended version of HISA is **constitutionally compliant** because it fixed defects that the Fifth

Circuit had previously identified. The HISA law has also been upheld as constitutional in a separate lawsuit initiated by different plaintiffs that got **validated on appeal** to the Sixth Circuit.

In a 72-page brief filed July 5, the HBPA appellants laid out an argument based on the premise that the rewritten HISA statute that got signed into law late in 2022 still doesn't pass the constitutional sniff test.

"This Court has already struck down HISA once before," the

HBPA filing stated. "Then Congress tweaked the law in one respect, giving the FTC a modicum of additional power over the original design." **Cont.**

"Though it is understandable to desire to applaud 'a productive dialogue' between the branches, this Court's job is not to reward Congress for passing a marginally less unconstitutional law by declaring it constitutional. Laws do not get passing grades for improved effort. Nor is constitutional analysis like horseshoes or hand grenades, where close--or even just slightly closer--is good enough."

The HBPA filing continued: "This Court's job is to again tell Congress--'No.'"

Central to the HBPA's case is the principle in administrative law that Congress cannot delegate its legislative powers to other entities. In their brief, the horsemen argue that the HISA Authority is a private entity subject to that "private nondelegation" doctrine, and that it is wrong to intentionally grant it powers that evade the safeguards of constitutional design.

"An alternative way to think about private nondelegation is not to ask about the quantity of supervision authorized, but the quality of the powers delegated. This question is not how much surveillance and authority the FTC has, but what type of power the Authority wields," the HBPA filing stated.

"HISA is directly contrary to the historical understanding of private delegation. Ultimately the corporation is named the Horseracing Integrity and Safety *Authority*, and not Advisors or Administrators, because its purpose is not to advise the FTC or perform ministerial tasks. Its purpose is to exercise sovereign national authority [and] giving such governmental authority to a private corporation was and remains 'delegation in its most obnoxious form.'"

The HBPA filing put it this way: "The Authority establishes the programs, drafts the rules, makes policy decisions, exercises enforcement discretion, investigates individuals, seizes evidence, prosecutes industry participants, sits in judgment on them, issues sanctions, decides how much it wants to spend, and then decides how much it will take in taxes to fund that spending.

"It does all of this without appointment of its board members by the president, confirmation of those board members by the Senate, appropriation of its funds or authorization of its fees by Congress, review of its investigatory requests by a federal magistrate, or transparency to the industry and the public through accountability laws like the Freedom of Information Act, Federal Advisory Committees Act, or Government in the Sunshine Act."

The first time the HBPA plaintiffs attempted to challenge the original 2020 version of the HISA statute in federal court, on Mar. 15, 2021, the suit was dismissed more than a year later, on March 31, 2022.

The HBPA plaintiffs then appealed, leading to a **Fifth Circuit Court reversal** on Nov. 18, 2022, that remanded the case back to the lower court. In the interim, an amended version of HISA got signed into law on Dec. 29, 2022.

On May 4, 2023, the lower court deemed that the new version of HISA was constitutional. The HBPA plaintiffs swiftly filed another appeal back to the Fifth Circuit, which is where the case stands now.

The HBPA filing stated that, "this Court should approach the amended statute with a clean slate and hold it up to the high bar set for a delegation of government power to a private actor, as enunciated in its prior opinion. If this Court does so, it will see that the act again fails. Even as amended, the statute does not give the FTC pervasive surveillance and control over the HISA Authority."

At a different point in the filing, the HBPA took umbrage with HISA's funding mechanisms.

"The powers to set taxes and spend tax funds are legislative powers. The Authority has the power to tax--it is empowered by HISA to set a mandatory assessment that either states pay, or if states decline to pay, then covered persons must pay directly. This is a tax....These funds are not voluntary or charitable contributions from covered persons and states--these are mandatory, obligatory fees levied by law. Failure to pay them can result in fines and suspension from racing. Once these funds are collected, HISA allows the Authority to spend them without any FTC oversight."

Enforcement is also constitutionally problematic for the HBPA.

"The Authority has the power to search and inspect 'offices, racetrack facilities, other places of business, books, records, and personal property of covered persons that are used in the care, treatment, training, and racing of covered horses,' to issue subpoenas, to compel truthful and complete answers to inquiries, to undertake urine and blood tests without advance notice, and to exercise 'other investigatory powers of the nature and scope exercised by State racing commissions,' which the Authority has apparently defined to include the power to seize evidence....

"By contrast," the filing continued, "if the FTC wanted to conduct a search or seize evidence, it would need a warrant from a magistrate. For the Authority to conduct a search or seize evidence, it doesn't even have to let the FTC know, little less secure the advance approval of a federal magistrate. This is an unconstitutional mutation of executive power. The Authority also has the power to hold administrative hearings, weigh evidence, decide guilt, and issue sanctions. These are also executive powers...

"As a result, under the terms of the statute, horsemen are investigated and subpoenaed and their property is seized with zero pre-clearance from a federal official, little less an independent magistrate," the filing stated.

The HISA and FTC defendants now have the opportunity to file their own brief with the Fifth Circuit Court by Aug. 4.

## WEEKLY STEWARDS AND COMMISSIONS RULINGS, JUNE 27-JULY 3

### New York

**Track:** Belmont Park

**Date:** 06/27/2023

**Licensee:** Manuel Franco, jockey

**Penalty:** Three-day suspension

**Violation:** Careless riding

**Explainer:** For having waived his right to an appeal Jockey Mr. Manuel Franco is hereby suspended (3) NYRA racing days July 7th 2023, July 8th 2023, July 9th 2023 inclusive. This for careless riding during the running of the second race at Belmont Park on June 22nd 2023.

### NEW HISA/HIWU STEWARDS RULINGS

The following rulings were reported on **HISA's "rulings" portal** and through the **Horseracing Integrity & Welfare Unit's "pending" and "resolved" cases portals**.

This does not include the voided claim rulings which were sent to the *TDN* directly. Some of these rulings are from prior weeks as they were not reported contemporaneously.

One important note: HISA's whip use limit is restricted to six strikes during a race.

### Violations of Crop Rule

#### *Belterra Park*

## GUN RUNNER TO STAND FOR \$65K ON SOUTHERN HEMISPHERE TIME; GOLDEN SLIPPER BONUS

Three Chimneys Farm's multiple-leading sire **Gun Runner** (**Candy Ride {Arg}**) will stand to Southern Hemisphere time with a AU\$500,000 bonus to any progeny that wins the G1 Golden Slipper S., Doug Cauthen, the vice chairman of Three Chimneys Farm, [told TTR AusNZ](#).

The farm's stud fee of \$65,000 (AU\$98,000) is slightly less than the \$75,000 (AU\$110,000) he commanded last year on Southern Hemisphere covers. They are hoping to attract anywhere between 20 and 40 Southern Hemisphere mares this spring.

"The goal is to make him appealing," Cauthen said. "He's consistently bred to Southern Hemisphere time, but last year and this year, we've really tried to open him up more. He's bred a solid book in the past without it being a big book, because we're not looking for a big book. We're looking for quality."

The American Horse of the Year produced six individual Grade I winners from his first book of 127 foals en route to Champion North American first-crop sire honors. **Cont.**

He was also the leading sire of 3-year-olds in 2022, which included Echo Zulu, Gunite, Cyberknife and **Early Voting**.

"He's been spectacular, and everyone here is feeling blessed to have him at Three Chimneys," Cauthen said. "But we think the potential to continue this, and build on it, is right there in front of him. Who he's as good as, we'll find out in five or 10 years' time, but he's certainly been exceptional so far."

The AU\$500,000 bonus to any progeny of **Gun Runner** that wins the Golden Slipper S. is also on the table.

"Like the Kentucky Derby or any of these great races, just getting runners in the field is the hardest part," Cauthen said. "Time will tell but we think it's a legitimate possibility for **Gun Runner** to get horses into the Slipper, therefore we should offer a legitimate bonus."

Emirates Park bred its Golden Slipper winner Estijaab (Aus) (Snitzel {Aus}) to **Gun Runner** on SH time last year. She's currently heading back Down Under safely in foal to the stallion.

## STUDY CONFIRMS HAIR USE FOR LONG-TERM DETECTION OF BISPHOSPHONATES

A new study, called for in 2019 by the Grayson-Jockey Club Research Foundation, was published on the use of hair as a matrix for the long-term detection of bisphosphonates in horses.

"Over the past few years, bisphosphonate use has become a concern with regard to the welfare of Thoroughbred racehorses," said Jamie Haydon, president of Grayson. "We are very thankful for the generous support by Vinnie and Teresa Viola's St. Elias Stables and their ability to recognize the importance of this research in promoting equine safety and welfare."

The new study found that hair testing can be used to consistently detect bisphosphonates for up to six months after administration.

"Bisphosphonates are labeled for horses four years and older to manage navicular symptoms," said Dr. Johnny Smith, A. Gary Lavin Research Chair of Grayson. "Unfortunately, people were using them in young horses, which is detrimental because bisphosphonates inhibit bone resorption, can stay in a horse's system for years, and can have long-term effects on bone."

Previously published studies, including one conducted by the same group and funded under the same special call, demonstrated that in some cases bisphosphonates can be detected in blood and urine for extended periods of time, but detection using these matrices can be unpredictable and less consistent.

"Our study from 2020 showed that clodronate and tiludronate reside in the bone for extended periods," said the study's principal investigator, Dr. Heather K. Knych, who is with the K.L. Maddy Equine Analytical Chemistry Lab's Pharmacology section and the Department of Molecular Biosciences at the School of

Veterinary Medicine, University of California, Davis. "This can lead to lasting pharmacologic effects and increase the risks of injury to racehorses. Being able to detect bisphosphonates long term in hair benefits the athletes and increases the integrity of the sport."

Bisphosphonates are considered a banned substance for covered horses under the Horseracing Integrity and Safety Authority's Anti-Doping and Medication Control (ADMC) program. A covered horse that tests positive is subject to lifetime ineligibility.

## O'BRIEN SWEET ON PADDINGTON'S CORAL-ECLIPSE CLAIMS

Aidan O'Brien says that he is looking forward to seeing what Paddington (GB), the brilliant Irish 2,000 Guineas and St James's Palace S. winner, can do over an extra two furlongs in the Coral-Eclipse at Sandown on Saturday and says the colt has made rare progress this season.

Paddington provided O'Brien with a record 83rd Royal Ascot victory when slamming the 2,000 Guineas winner Chaldeen (GB) (**Frankel {GB}**) in the St James's Palace.

The master of Ballydoyle went on to secure his 85th winner at the royal meeting before passing another important milestone at the Curragh on Sunday when Auguste Rodin (Ire) (Deep Impact {Jpn}) provided the 53-year-old with his 100th European Classic success with a hard-fought Irish Derby triumph.

O'Brien will be hoping for more big-race success at Sandown on Saturday and drew comparisons between Paddington and his most recent Coral-Eclipse winner St Mark's Basilica (Fr).

Both colts are the highest-rated sons of **Siyouni (Fr)**, and it's their ability to quicken that marks them down as something out of the ordinary, according to O'Brien.

He told *TDN Europe*, "Paddington came out of Ascot really well and we always felt that he'd get further than a mile. I suppose what makes them different [the progeny of **Siyouni**] is the way that they quicken." **Cont. p3**

## LOPE DE VEGA'S LA FILOMENA ANCHORS TRADE AT ARQANA

The second and final day of the Arqana Summer Sale featured both breeding stock and horses in training, and it was one of the latter contingent, **La Filomena (Ire)** (Lope De Vega {Ire}) (lot 480), who proved the most expensive at €395,000 on a bid from Stuart Boman of Blandford Bloodstock on behalf of Speriamo Bloodstock's Larry Young.

Offered by Jean-Claude Rouget, who led the way as a vendor during the second day with six sold for a gross of €734,000, the George Kent-bred 3-year-old filly placed at two and has won twice from three starts at three for Peter Brant's White Birch Farm. The full-sister to stakes winner and Group 3-placed Epic Poet (Ire) was also third in the Listed Prix Melisande at ParisLongchamp in June. Under the second dam is three-time Group 1 winner and new Darley stallion Perfect Power (Ire) (Ardad {Ire}). **Cont. p4**

The trainer added, "St Mark's Basilica was the very same, he used to quicken off a good pace and this horse does that as well, doesn't he? The Siyounis are really able to quicken and Paddington is a very exciting prospect."

O'Brien added, "Paddington has done everything we've asked of him so far and seems to be progressing with every run. We're very happy with him and hope he runs a big race on Saturday. We've been happy with him since Ascot."

The Sussex S. at Goodwood had been mentioned as the most likely option for Paddington after his Ascot triumph but O'Brien has said that, given how well the colt came out of the royal meeting, connections were keen to explore the possibility of stepping him up to 10 furlongs for the Sandown showpiece, for which he is a top-price 11-8 favourite.

Like former Group 1-winning Ballydoyle-trained inmates Homecoming Queen (Ire) (**Holy Roman Emperor {Ire}**) and Treasure Beach (GB) (Galileo {Ire}), Paddington cut his teeth in handicaps before achieving success at the highest level, with O'Brien describing his progression as "unusual".

On the decision behind running at Sandown, he said, "We thought he could do both [Sussex and Coral-Eclipse], really, and when it was when he came out of Ascot so well that we decided

to aim him at the Coral-Eclipse.

"We can just explore a little bit with him. We saw what he did at the Curragh and at Ascot over a mile so we're looking forward to seeing him run on Saturday."

O'Brien added, "He's made very good progress from run to run, I suppose you could describe it as unusual progress, really. He's just a very natural horse."

Auguste Rodin (Ire) (Deep Impact {Jpn}) led home an O'Brien-trained 1-2-3-4 in the Irish Derby on Sunday and is reported to have come out of that scrap in good heart. The long-term plan could be to revert to 10 furlongs with the dual Derby winner for either the Irish Champion S. or the Juddmonte International, but first, a tilt at the King George at Ascot is under consideration.

O'Brien said, "We were delighted with Auguste Rodin. He's a great traveller and seems to have a great capacity. He's come out of the Curragh well and we're looking at the King George for him now.

"I know it's a little bit down the road but we thought that if we did go for the King George, then he could have a little bit of time after that and come back for either an Irish Champion Stakes or a Juddmonte International."

## FOZZY STACK: 'ASPEN GROVE HAS NOTHING TO LOSE IN BELMONT OAKS'

Fozzy Stack says that Aspen Grove (Ire) is something of a forgotten horse heading into the GI Belmont Oaks Invitational S. and revealed that there were genuine excuses for her below-par effort in the Irish 1,000 Guineas when the **Justify** filly was found to be in season.

Aspen Grove carried Craig Bernick's distinctive silks to victory in a Group 3 contest at the Curragh last term and, with that valuable black-type success already secured, Stack felt connections could afford to be brave in travelling her over for Saturday's Grade I assignment.

Stack said of the filly who is also co-owned by Mrs. John Magnier, "She was in season when she ran in the Irish 1,000 Guineas so there was very much a plausible excuse for that effort. There's only one Guineas, she couldn't run in it next year, so that's why we took our chance.

"Listen, she's travelled over well and she seems to have settled in nicely. Mark Enright is over here with her and he is happy with her so we'll see what happens."

He added, "She has good form. She ran very well on her reappearance at Leopardstown when third in a Group 3 despite being caught wide the whole way round.

"You could run around in Group 3s at home in Ireland for forty grand or you can come over here for a lot of money. She's already a Group 3 winner so she's nothing to lose and it all to gain."

Aspen Grove is a general 8-1 chance with most firms for the Belmont Oaks and will have the assistance of Oisin Murphy in the saddle.

Murphy's primary reason for jetting out Stateside is to ride

Andrew Balding's The Foxes (Ire) (**Churchill {Ire}**) in the Belmont Derby and Stack said that it would have been "silly" not to snap up a rider of his quality for Aspen Grove.

He said, "It made a lot of sense to get Oisin to ride the filly. He's coming over to ride The Foxes for Andrew Balding anyway so it would have been silly not to use him while he's here."

Stack has enjoyed a good start to his domestic campaign in Ireland and is operating at a 17 per cent strike-rate with 11 winners under his belt.

Indeed, he has already tasted big-race success on American soil when Yesterdayoncemore (Ire) (**No Nay Never**) won a Grade II at Del Mar in 2019.

Like Yesterdayoncemore, Stack says that Aspen Grove could well continue her career in America for Bernick, who he describes as an important supporter of his famous County Tipperary stable.

Stack said, "We'll get this over with first, but we will probably run her at Saratoga or at Del Mar after this. I'm very lucky to have Craig as an owner. He's a very nice guy and has a great interest in the game. He actually bred Aspen Grove."

On the race itself, he added, "Graham Motion's filly [Mission Of Joy (Kitten's Joy)] sets a good standard and Chad Brown has a couple of nice fillies [Aspray (**Quality Road**) and Prerequisite (**Upstart**)] in there as well.

"There are no easy Group 1 races wherever you go but they are usually not as difficult to win on the grass in America than they are in Europe so hopefully she can go close."

Boman said of the 210,000gns Tattersalls December foal turned 310,000gns Tattersalls October Book 1 yearling, "She's a lovely filly with a great pedigree. This type of filly is hard to find. She is lightly raced and has already shown herself at listed level. Her sire is a good stallion and she hails from a great family that we know well as we bought Perfect Power."

AQPS gelding **Jamaico (Fr)** (Cokoriko {Fr}) brought €310,000 from Hubert Barbe's Horse Racing Advisory, Thursday's leading buyer, who signed for two lots for a total of €400,000.

Consigned by Emmanuel Clayeux, lot 505 has won once over jumps at Auteuil this year and was bred by the Cypres family.

"I've bought him for Caroline Tisdall who has horses in training with David Pipe," said Barbe. "She really wants to have a good chaser that could run at all the big meetings." [Cont. p5](#)

Barbe added, “He has everything going for him. He made a really nice comeback in a bumper at the beginning of the season and still has a lot of improvement in him. We had to battle a bit to get him, so we are very happy.”

**Full Of Shade (Fr)** (No Risk At All {Fr}) (lot 495), another horse from the jumps sphere, went to Pierre Boulard of PB Bloodstock, Harold Kirk and Willie Mullins for €280,000. Consigned by Ballyreddin and Busherstown, the placed 4-year-old filly is a half-sister to graded winner The Reader (Fr) (Lando {Ger}) and listed scorer Vintage (Fr) (Nickname {Fr}).

Boulard said, “She’s a lovely mare by No Risk At All, a stallion that we think a lot of. We’re really happy with our purchase.”

No Risk At All also featured as the covering sire of lot 290, **Sideralis (Fr)** (Kapgarde {Fr}), the sale’s top-priced broodmare. The Haras de la Vallee-consigned mare went to Jean-Christian Raymond and Thomas Maudet for €145,000.

“Her pedigree speaks for itself,” Raymond said. “She’s a daughter of Kapgarde, a very good broodmare sire, and she’s in foal to an excellent stallion in No Risk At All. Maurice Rohaut, his son Francois and Jean-Marie Mercier introduced me to Thoroughbreds. She is my eighth mare and I’m very happy.”

The Aga Khan’s homebred **Hamsiyann (Ire)** (Lope De Vega {Ire}) (lot 473) caught the eye of Toby Jones for €250,000. Part of the Aga Khan Studs’ draft, the son of Harasiya (Ire) (Pivotal {GB}) won a 2300-metre race at Tarbes in June in the colours of his breeder, his second victory in six starts. He is from the family of G3 Prix de Guiche winner Big Rock (Fr) (Rock Of Gibraltar {Ire}), who was runner-up in the G1 Prix du Jockey Club.

“He’ll join Tony Martin in Ireland,” said Toby Jones. “He’s a lovely horse and I really liked the way he won on his last start.”

Fabrice Vermeulen’s **Mqse De Maintenon (Ire)** (Muhaarar {GB}) (lot 487) brought €185,000 from David Hilton and

Oakgrove Stud. The dual winner was placed in the Listed Prix des Lilas this term and is a half-sister to the multiple group-placed Shamardal filly Grecian Light (Ire).

“We’re delighted,” said Hilton, who manages Oakgrove. “It’s a family that we know well and we’re very pleased to support it once again. The filly is very talented and I think she still has a lot to offer. We have a good programme for fillies in England and we can’t wait to see her race there.”

During Thursday’s session, 164 sold of 189 offered (86.7%) for a gross of €5,742,000. The average declined fractionally to €35,012 (-1.8%) and the median rose to €14,000 (+27.3%). For the sale as a whole, 346 sold of 411 through the ring (84.2%) for a gross of €11,833,750. The average was €34,202 (-0.6%) and the median was €20,000 (+25%). Guy Petit was the top buyer by aggregate, with five purchased for a total of €453,000 during the two-day stand. The Channel Consignment filled that same role among the consignors, with 22 sold for a gross of €1,435,000.

Arqana President Eric Hoyer and Executive Director Freddy Powell said, “The two days of sales came to a close with very good results across the board. After an exceptional sale last year, it was sustained across all categories with strong demand for the top-of-the-range profiles, such as the historic top price achieved during the stores section yesterday for a son of **Zarak (Fr)** offered from The Channel Consignment that was bought for €240,000 by Guy Petit. As usual, we would like to extend our warmest thanks to our vendors, as well as to the many buyers who made the trip to Deauville. We will now turn our attention to August, which this year will host the first edition of the Arqana Series on the eve of the August Sale.”

## ANMAAT OUT OF ECLIPSE, FOUR REMAIN

Saturday's G1 Coral-Eclipse is down to just four after one of the main protagonists **Anmaat (Ire)** (Awtaad {Ire}) was ruled out at the 11th hour due to a foot abscess. **TDN Rising Stars** **Paddington (GB)** (Siyouni {Ire}), **Emily Upjohn (GB)** (Sea The Stars {Ire}) and **West Wind Blows (Ire)** (Teofilo {Ire}) are joined

by this year's G1 Ranvet and G1 Queen Elizabeth S. hero **Dubai Honour (Ire)** (Pride Of Dubai {Aus}) as Shadwell's G1 Prix d'Ispahan winner was forced to skip the contest.

"It's just a matter of timing, he'll be fine next week hopefully," Angus Gold said. "It's a big blow to Owen [Burrows] and the team there and obviously Sheikha Hissa and all at Shadwell. Off the top of my head we could look at something like the Irish Champion S., but that is obviously a while away yet. The Eclipse was his prime summer target, but there we go."

Emily Upjohn, so impressive in the G1 Coronation Cup last time, was declared without the hood she sported in the G1 British Champions Fillies & Mares S. and at Epsom last time. As announced earlier in the week, William Buick will partner the Gosdens' 4-year-old, who will look to provide the Lloyd Webbers and Buick with more joy than The Fugue (GB) (Dansili {GB}) who was last of seven in the 2013 edition and Dar Re Mi (GB) (Singspiel {Ire}) who had beaten only one of the five runners three years earlier. ## DERBY PROTESTOR SPARED JAIL TIME AFTER 18-WEEK SENTENCE SUSPENDED

Ben Newman, who **was filmed running onto the Epsom Downs course after the Derby had started and was subsequently apprehended by security in June**, was spared jail time after his 18 weeks of imprisonment was suspended for two years, *Sky Sports* reported on Thursday. The defendant, 32 and part of protest group Animal Rising, was also fined a total of £1,356.

The defendant entered a guilty plea at Guildford Crown Court for causing a public nuisance. The judge criticised Newman for "endangering" the lives of police and security stationed around the course. **Epsom Downs obtained an injunction banning Animal Rising** prior to the Derby Festival. Newman was one of 31 people arrested on the day of the race.

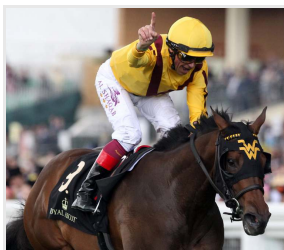

**WORLDWIDE NEWS****PURSES INCREASED FOR 2023-2024  
MEYDAN RACING SEASON**

Horses racing over the Meydan turf | Dubai Racing Club

Purses will rise 27% during the 2023-2024 Dubai racing season at Meydan Racecourse, the Dubai Racing Club (DRC) announced earlier this week.

The new minimum purse of AED165,000 will be for non-stakes races, while all Group 1 races will be increased to a purse of at least AED1million. The prize-money of \$30.5 million on Dubai World Cup night will remain unchanged. In addition, all Meydan cards will feature nine races except for the first two.

Other changes revealed by the DRC include two new feature race nights: Festive Friday on Dec. 22 and Fashion Friday on Jan. 26, while Super Saturday will be held on Mar. 2, and Dubai World Cup night is set for Mar. 30. Racing at Meydan begins on Friday, Nov. 10.

"The DRC management and board have decided to reshape racing in Dubai, to improve sustainability in line with what is happening in the region," said Major General Dr. Mohammed Essa Al Adhab, Executive Director of Dubai Racing Club. "Today, many countries are going along with Dubai and the UAE by using racing to showcase their development, a journey which Dubai started much earlier.

"The Dubai Racing Carnival has now become the whole season. Horses can now come to Dubai from the start of the season until the Dubai World Cup."

Stephanie Cooley, International Manager for DRC, added, "From an international perspective, we still have our quarantine facilities, plus trainers also have the option of shifting over to a local stable. **Cont. p14**

She added, “It’s a more condensed season but we have retained all of the feature races and aligned them more with some of the bigger races in the region.”

British horses will also now have more travel options when visiting the Middle East.

“Horses trained in the UK have the option of 90 days temporary import, with the option of going in and out,” said Erwan Charpy, Advisor to the DRC. “They can also come on a permanent import and go back with a 30-day quarantine or go back as temporary import. There are discussions to get England to line up with the regulations in the European Union, as since Brexit there is almost no problem with horses going back to the EU without quarantine on a permanent import.

“The import certificate was previously just for the Dubai Racing Club, but now it is for the Middle East, which allows for more freedom of movement.”
